

# Arizona Community Third Party Trust

Funded Trusts- Services being provided  
Fee Schedule 2024

**Set Up Fee:** New Clients Only \$1,500.00

*A one-time fee to join the PLAN of AZ pooled trusts. This fee includes initial meetings with the Grantor(s), education on pooled trusts and appropriate disbursements, budgeting, preparation of other documentation necessary to set up the sub-trust account and the initial reporting of the Trust to Social Security and Medicaid. \$500 of this fee is payable to PLAN of Arizona at the execution of the Joinder Agreement by the Grantor(s) and the balance will be taken from the Trust when it funds.*

**Sub-Trust Administration Fee\*:** 1.75% of the FMV

Account market value \$15,000 and under \$60.00 (min)

Account market value \$15,001 to \$25,000 \$85.00 (min)

Account market value \$25,001 to \$50,000 \$100.00 (min)

Account market value \$50,001 to \$750,000 1.50% of the FMV

Account market value \$750,001 to \$1,000,000 TBD

Account market value \$1,000,001 and over

*This includes monthly trust administration, budgeting, processing disbursement requests, bill pay, billing and communication with the beneficiary, Grantor or Primary Representative about disbursements.*

**\*The annual fee will be charged on a monthly prorated amount based on your account balance at the end of each month.**

**Care Management:** Hourly (billed in quarter hours) \$80.00

*Additional services including, but not limited to, companions, social workers, home visits/monitoring, shopping, appointment and service coordination, scheduling transportation, benefit assistance, employment support, coordination with community and medical services, staffing and court attendance by PLAN employees. Any subcontracted care providers will be billed at their current rate.*

**Transportation mileage: 65.2 cents per mile. A travel charge of \$30/hr. to and from the beneficiary's location may apply for drive times beyond 30 min. A no show fee of \$80 will be billed if the beneficiary does not cancel at least 2 hours prior to the appointment.**

## Miscellaneous Fees

**True Link Paper Statements:** Quarterly (optional, online access is free) \$2.50

**True Link Card Fee:** Monthly No Charge

**True Link Investment Fee:** This fee will be charged, pro rata, to each sub-account on a monthly basis. .7%

**Real Estate Fee:** Annually (per parcel) \$130.00

**PLAN Tax Preparation Fee:** Annually \$65.00

**CPA Fee to Prepare Fiduciary Tax Returns:** Annually (passed on from CPA) \$85.00

**PLAN of Arizona Termination/Closing Fee** \$500.00

All fees are subject to change at the beginning of each year.
